

**ENROLLMENT GUIDELINES**  
**BROWN COUNTY PRE-KINDERGARTEN PROGRAM**  
**SCHOOL YEAR: 2025-2026**

**PROGRAM ELIGIBILITY**

1. The child must be 4 years of age by August 1st 2025 for the 2025-2026 school year for the following schools: Ripley Elementary, Sardinia Elementary, Russellville Elementary, Mt. Orab Elementary, Fayetteville Elementary, and Hamersville Elementary.
2. The child must be completely toilet trained. This means the child must be able to attend to bathroom needs independently. A child who wears pull-ups and is not considered toilet trained.

**THE FOLLOWING INFORMATION MUST BE SUBMITTED WITH THE ONLINE APPLICATION:**

- **INCOME VERIFICATION:** The front page of your 2024 income tax return showing the household's *adjusted gross annual income*. A 10-40 document OR a W-2 document from both parents. Two consecutive income verification forms/pay stubs from both parent's/guardian's employers is acceptable as well. \*\*\* *Income refers to all money that you and the people in your home receive, such as earnings from employment, child/spouse/medical support, disability benefits, retirement benefits, Workers' Compensation, Social Security, SSI, and/or Veterans benefits*\*\*\*
- **ECE Grant for Free or Reduced Tuition -** *The Department of Job and Family Services will be determining eligibility.* To see if you qualify for the grant you will need to complete the following steps:
  - View **Poverty Guidelines** to see if you qualify for grant (If you don't - do not proceed to next step - you will be required to pay full tuition)

  - Create an account
  - Click "Check Eligibility for Early Child Services"
- **COPY OF BIRTH CERTIFICATE:** Required to gain enrollment
  - ❖ **Custody Papers or Foster Child/Kinship Placement Documents <> if Applicable**
  - ❖ **Completed Online Application with uploaded documents and all forms completed by signing and dating.**
  - ❖ **Residential Parent's Driver's License -**
  - ❖ **Proof of Address (Utility Bill) - Required to gain enrollment**
  - ❖ **Child's Immunization Record**
  - ❖ **Medical Statement (By the 1st day of school)**

**An incomplete application/any missing forms will cause your child not to be enrolled into preschool or be placed on the waitlist.**

### **Student Eligibility:**

The Ohio Department of Education has set the target population for the Early Childhood Education Grant Program. The pre-kindergarten program will primarily serve children who are 4 years of age by August 1st (*Eastern, Fayetteville & Western Brown*) or 4 years of age by September 30th (*Ripley*). **Students must be completely toilet trained and able to function independently in the restroom to be eligible for enrollment. A child who wears pull ups is not considered to be toilet trained.** Applications for children who are 3 years old will be considered for enrollment *AFTER* approval is requested by the supervisor and granted by the Ohio Department of Education in early November, provided all slots have not been filled with 4-year-old students. Children ages 3-5, **who have special needs**, are eligible for enrollment and will receive services outlined in an Individualized Education Plan. Families/guardians are required to reapply and submit updated income information if their child returns to the program for a second or third year.

### **Tuition Consideration:**

Parents whose children are 5 years of age by August 1st (*for Eastern, Fayetteville, & Western Brown*) or September 30th (*Ripley*) may opt to enroll them in the Pre-Kindergarten Program, but please note that the maximum tuition rate will be charged regardless of the family size or income level because the child is now considered to be kindergarten eligible based on their age.

### **Program Description:**

Involvement in the pre-kindergarten program provides enriching experiences to enhance each child's creative, language, social, emotional, physical, and cognitive development. Preschool *Curriculum* is used to introduce students to the pre-kindergarten early learning and development standards as adopted by the Ohio Department of Education. Classroom activities are planned so that children can work independently, in small groups, and in large groups. Parents are welcome to volunteer in the classroom or help with special projects, per building and district volunteer guidelines/requirements.

Children from households with income at or below eligible levels may receive free or reduced price meals. Applications are available at parents request at each of the buildings. Children who qualify for Special Education Services will not be required to pay tuition.

Tuition payments are due the 1st of every month (September-April). **Attendance will be suspended if tuition is not paid.** Tuition adjustments can be made during the school year with proper documentation of change of income or prorated based on the date of enrollment.
