A. Set The Columbus Dispatch and The Newark Advocate as the official newspapers for notices to the public during CY2025.

B. Authorize the Treasurer to pay bills, payroll, and other obligations, within the appropriations resolution, as due each month.

C. Authorize the Treasurer to adjust account balances as necessary to provide for encumbrances in all funds, including the adjustment of necessary dollar amounts within a specific fund for salary, sick, personal, and vacation leave accounts in order to balance accounts.

D. Authorize the Treasurer to issue blanket purchase orders and "super" blanket purchase orders in accordance with ORC 5705.41(D), except any single purchase contracts in excess of \$25,000 shall be affirmed by a separate board resolution.

E. To appoint the Treasurer, as the Public Records Designee to receive training for the Board of Education.

F. Authorize the Treasurer to invest active, inactive, and/or interim funds as cash flow permits.

G. Appoint the Treasurer to serve as the credit card compliance officer to review officers' and employees' use of credit card accounts at least once every six (6) months under board policy.

H. Authorize the Superintendent to be designated as the Purchasing Agent to approve purchases within the annual appropriation resolutions.

I. Authorize the Superintendent and the Treasurer to participate in all appropriate federal and state grant programs and to file the required applications and reports.

J. Designate the Superintendent, Treasurer, and Board Members as Tax Incentive Review Commission (TIRC) representatives for the District CY2025.

K. Establish a Board Service Fund for the payment of expenses actually incurred by Board members in the performance of their duties or members-elect in training and orientation to the performance of their duties (R.C. 3315.15).

L. Approve for the purchase of coffee, meals and/or refreshments for meetings for the purpose of school business, at the discretion of the Superintendent, in conjunction with the Board.

M. Approve the renewal of faithful surety performance bonds through the 2026 Organizational Meeting for the Superintendent, Treasurer and Board President.

N. Authorize participation in the following cooperative purchasing programs, as needed:

- 1. DAS State Cooperative Purchasing Program
- 2. Metropolitan Educational Technology Association (META) Solutions
- 3. U.S. Communities Government Purchasing Alliance (USCGPA)
- 4. Ohio School Benefits Cooperative (OSBC)
- 5. The Energy Cooperative

O. Establish a Records Commission composed of the President of the Board of Education, The Treasurer of the Board and Superintendent of Schools. The Commission shall meet at least once per year and establish rules for retention and disposal of records and to review the same.

P. Authorize the Superintendent, Treasurer, and Board President to use legal services of the Licking County Prosecutor, Delaware County Prosecutor, Bricker and Graydon, L.L.P., Scott Scriven, L.L.P. and/or other legal services with expertise and experience with public school laws; special education laws, labor issues, financial issues and other legal matters pertinent to the operation of a school district.

Q. Approve renewal of membership in the Ohio School Boards Association in the amount of \$6,952 for dues, school management news by email at \$150, virtual transportation supervisor subscription at \$300, plus legal assistance fund at \$250.

R. Authorize the Superintendent to employ temporary personnel with notification and subsequent approval sought at the next Regular Board meeting.

S. Authorize the Superintendent to immediately accept resignations from any staff member during times when the Board is not in session.

T. To approve membership in the Ohio Education Policy Institute (OEPI).

U. Approve joint agreement appointing the Business Advisory Council of the Licking Regional Educational Service Center to serve as the business advisory council for the school district.
