

Student Code of Conduct – Introduction

At Englewood on the Palisades Charter School (EPCS), we believe that learning flourishes in a safe, respectful, and supportive environment. All students are expected to attend school regularly, arrive on time, give their best effort in the classroom, and uphold the rules and expectations that keep our community strong. These expectations reflect our school motto, *“Together We Work, Together We Succeed,”* and our 2025–2026 theme, *“Ready. Set. Succeed.”*

We ask every student to show respect for themselves, their peers, their teachers, and all members of the EPCS community. When challenges arise, we rely on a partnership between home and school—parent/guardian support and follow-up at home are essential in helping students grow from their mistakes and develop positive habits.

EPCS staff are committed to using proactive and educational approaches to discipline. Our teachers and staff emphasize prevention by setting clear expectations, designing engaging lessons, and building strong relationships with students. When additional support is needed, we use restorative practices, counseling, and incentive-based programs to guide students toward responsibility and accountability.

Restorative Practices at EPCS

Restorative practices are an essential part of how we build our school culture. They encourage students to reflect on their actions, repair harm, and strengthen relationships within our Cougar community. These practices include:

- **Affective Statements:** Honest, respectful communication that helps students understand the impact of their behavior.
- **Restorative Dialogues:** Guided conversations that allow students to share their perspectives, accept responsibility, and determine how to make things right.
- **Restorative Meetings/Conferences:** Opportunities for those affected by conflict to come together, promote understanding, and agree on solutions that repair harm.

Through these processes, students learn to take responsibility, practice empathy, and contribute positively to the school environment. 1



Interventions and Consequences

When rules are broken, our responses are designed to balance accountability with opportunities for growth. Interventions may include teacher-led redirection, reflective activities, lunch or after-school accountability sessions, restorative circles, or, when necessary, suspension. For students with disabilities, interventions are provided in accordance with state and federal guidelines (N.J.A.C. 6A:14).

Above all, EPCS expects students to resolve conflicts constructively, seek help from staff when needed, and avoid verbal or physical confrontations. Serious or repeated misconduct may result in suspension and/or referral to outside agencies, including the Englewood Police Department. Additionally, students who choose not to meet our expectations may lose the privilege of participating in extracurricular activities, field trips, or special school events.

Off-Campus Conduct

While the formal discipline code applies to school hours and school-sponsored events, we expect our Cougars to represent EPCS with pride wherever they go. Poor choices outside of school can still affect our school community. As such, students who engage in harmful or disruptive behavior off campus may face loss of privileges or other interventions, as determined by school administration.

At EPCS, discipline is not about punishment—it is about teaching, growth, and responsibility. Together, with the support of families and staff, our students are prepared to live up to our motto and theme: *“Together We Work, Together We Succeed!”*



Behavior/Violation Chart

When necessary, it can be expected that one or more of the following actions will be taken. While this chart is a guide for behavior violations, the administration will make decisions on a case by case basis depending on the severity of the behavior. These consequences balance discipline with opportunities for learning and personal growth, promoting respect and a positive school culture. We expect all students to be upstanders in the community and conduct themselves with pride and positive behavior, both in and out of school. To that end, please be aware that students may be subjected to consequences including, but not limited to: • disciplinary action (i.e. interventions)

- removal of privileges (including participation in extracurricular activities, athletics, promotion ceremony, and field trips)
- behavioral interventions as determined appropriate by EPCS administration
- the involvement of law enforcement and other outside agencies as necessary

- Behavior Contract- Establish a written agreement with specific behavior goals and consequences for further infractions.
- Mandatory Counseling- The student engages in ongoing sessions with the counselor

Engaging in physically aggressive behavior, beyond minor altercations, that creates a significant risk or results in injury.		
Fighting Including shoving, pushing, spitting, or engaging in an altercation or similar physical confrontational behavior, with students or staff members.		
Menacing Behavior any intentional act, gesture, communication, or conduct that is reasonably perceived as threatening, intimidating, or intended to cause fear of harm to another individual. Such behavior may be directed toward students, staff, or any member of the school community and may occur in person, in writing, electronically, or through physical presence. Gross Disrespect

Gross disrespect is defined as any behavior, language, or gesture that is overtly rude, defiant, or demeaning toward a staff member, student, or member of the school community, and that substantially disrupts the learning environment or undermines the authority of school personnel. Such conduct goes beyond ordinary misbehavior and reflects a serious disregard for school rules, staff directions, or the dignity of others.

Examples include, but are not limited to:

- Using abusive, profane, or offensive language directed at a staff member or student.
- Refusing to follow direct instructions from staff in a confrontational or defiant manner.
- Mocking, ridiculing, or belittling a staff member or student in a way that

- Violent behavior

- Cheating or plagiarism
- Sexism, racism, homophobia, or prejudice

Disciplinary Action will be determined based on the severity of the infraction.
